Extra-Class Participation Contract-Athletics

Extra-Class Participation Contract – Athletics:

In order to participate in school-sponsored extra-class activities at Daphne High School, I must pass at least six new Carnegie units with a minimum composite numerical average of 70 in those six units. Four core curriculum courses (English, math, science, social studies) must be included in those units passed and averaged. I must also complete a NFHS Sportsmanship online interactive course.

Daphne High School Student Athlete Pledge:

As a student athlete, I am a role model. Using inappropriate language, taunting, baiting, or the use of unwarranted physical contact directed at opposing players, coaches, and fans, or my fellow Trojans is contrary to the spirit of fair play and the good sportsmanship that my school, my conference, and the AHSAA expects of its members. I accept my responsibility to model good sportsmanship that comes with being a Daphne High School student athlete.

Parent Pledge:

As a parent I am a role model. I will remember that school athletics are an extension of the classroom, offering learning experiences for the students. I will show respect for the opposing players, coaches, spectators, and support groups that will participate in cheers that support and uplift the teams involved. Using inappropriate language and taunting are contrary to the spirit of fair play and the good sportsmanship of our school, conference, and the AHSAA expectations of its members. Additionally, I will support my son/daughter and Daphne High School in maintaining high academic standards by helping him/her to meet all academic and attendance requirements to remain eligible to participate. I accept responsibility to support my son/daughter's academic performance and to model good sportsmanship as a parent of a student athlete. I certify that the home address shown in this document file is my sole bona fide residence, and I will notify the school principal immediately of any change in residence, since such a move may alter the eligibility status of my student-athlete. All other information contained in this form is accurate and correct.

Athletic Scholarships:

Our family understands that students who receive scholarships to colleges and universities on a regularly basis have achieved both on and off the field. Colleges and Universities are looking for Student Athletes. Students who want to be considered for scholarships need to maintain a GPA of at least 3.2 as well as performing sufficiently in their Sport.

AHSAA Sportsmanship/Ejection Policy:

We acknowledge that we, both the student and parent whose names appear below, have read and understand the AHSAA Sportsmanship and Conduct/Ejection Policies and the consequences for violation. We understand that the types of behavior that will result in an ejection from an athletic contest include but are not limited to fighting, taunting or baiting, profanity directed at an official or an opponent, obscene gestures, and disrespectfully addressing an official or others.

First Ejection: A \$300 fine (An athlete's fine can be reduced to \$100 if the athlete being ejected takes the online NFHS Captain's Course and payment is made within 10 days of the date of the ejection.)

Second Ejection: A one-game suspension and a \$500 fine.

Third Ejection: Minimum penalty of a suspension for the remainder of the season plus a \$750 fine.

Transportation for Athletic Events:

If student transportation is by a Baldwin County Schools bus, the school system transportation liability coverage is applicable to any vehicular accident. If student transportation is by private vehicle, the vehicle owner's liability coverage is applicable to any vehicular accident. Parent or adult drivers should be aware that they may be held responsible for injuries to any individuals they are transporting and must certify that any private vehicle used is covered by at least the Alabama state required insurance coverage. Students are **never** allowed to transport other students to and from co-curricular events. Buses are always preferred; however, when personal vehicles are used parents must sign a liability release when their child will be riding with another parent.

Medical Authorization:

As the parent or legal guardian of this student athlete, I grant permission for treatment deemed necessary for a condition arising during or affecting participation in sports, including medical or surgical treatment recommended by a medical doctor. I understand that every effort will be made to contact me prior to treatment. Also permission is granted to release medical information to the school and athletic trainer.

We, the undersigned student and parent(s)/guardian(s), have read this document and understand all of the aforementioned requirements necessary for athletic participation at Daphne High School and agree to comply with the requirements set forth in this document.
