
ITEM: Declaration of an Emergency for Replacement of Chillers at Daphne High School

Background Explanation:

Approximately two weeks ago, during investigation of cooling problems at Daphne High School, water was discovered in the chiller barrel. This contamination of the fluid in the chiller barrel reflects significant leaks in the cooling system. After review of the issue it was determined that the units would be costly to repair. The units are around fourteen (14) years old. By having to wait for engineer's drawings, advertising, bidding and award by the Board, timing would take the project well into the start of school. **Code of Alabama, Section 39-2-2(e)** allows the Board to declare an emergency for convenience that will allow the Board to move forward with the construction without having to go through the advertising process. This work needs to be done in time for the start of school.


Recommendation:
