

Cheer Tryout Commitment Form

THIS DOCUMENT CONTAINS A COMMITMENT, CONSENT AND WAIVER. READ BEFORE SIGNING. SIGNING THIS DOCUMENT AFFIRMS THAT YOU HAVE READ IT AND UNDERSTAND IT IN ITS ENTIRETY.

In consideration for my child being permitted to try out for the 2022-23 Spanish Fort High School Cheerleading team as part of the 2022 Spanish Fort High School (SFHS) Spring Cheerleading Tryouts (“Activity”), I, as the parent and/or legal guardian of the minor (if participant is under 19 years of age) named below, do hereby:

1. Acknowledge that a signature of parent or guardian, is required in order to participate in the Activity. I further acknowledge that I am aware of, and I understand, that there is a risk of harm, including but not limited to risk of injury to person or property and/or death in should I choose allow my minor to participate in this Activity.
2. Acknowledge and represent that as the parent or legal guardian of the below minor, I have general liability and health insurance coverage.
3. Consent to my minor’s participation in the Activity and hereby release, discharge and hold harmless the **Baldwin County Public School System**, its Board members, activity officials, activity organizers, tournament directors, employees, volunteers, members, and other participants, (“Released Parties”), from all claims, demands, actions, judgments, and executions which the signed names on the form below ever had, now has, or may have or claim to have. This includes any and all claims against any present or future claim, loss, or liability for personal injuries, known and unknown, injuries to property, real or personal, caused by, or arising out of my or my minor’s participation in the above-mentioned Activity.
4. Acknowledge and understand that my child is being permitted to participate in the Activity, because I commit to enrolling, or pursuing the required paperwork and following the appropriate procedures, so that my child may enroll and attend SFHS for the 2022-23 school year.
5. Acknowledge and understand that as a condition to my child being permitted to participate in the Activity, I will be required to pay a \$350 deposit **prior to** the day of the Activity. Should my child not be selected as a member of the team, I understand that I will be refunded my deposit. If my child is selected as a member of the team, however, and in the event that my child *is not* enrolled and/or *does not* attend SFHS for the 2022-23 school year, **I understand and accept that I will not receive a refund of this deposit,** as I acknowledge that this money will be put forward to costs associated with the purchasing of my child’s uniforms and equipment and that such ordering must occur prior to the beginning of the 2022-23 school year.

BY SIGNING BELOW, I AM ACKNOWLEDGING THAT I HAVE READ THIS CAREFULLY AND KNOW IT CONTAINS A COMMITMENT, CONSENT, AND RELEASE. I EXECUTE THIS AGREEMENT VOLUNTARILY AND WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE.
